Check the location where the range is to be installed. The range should be positioned for convenient access in the kitchen.



NOTE: Observe all governing codes and ordinances.

Any openings in the wall or floor where the range is to be installed must be sealed.

Some cabinet and building materials are not designed to withstand the heat that the oven produces during baking. Check with your builder or cabinet supplier to make sure that the materials used will not discolor, delaminate or sustain other damage.

The cabinet opening dimensions that are shown must be used. The indicated dimensions are the minimum clearances.

When installing a range under existing cabinets that do not satisfy the minimum cabinet clearances, install a rangehood over the cooking surface to avoid burn hazards.

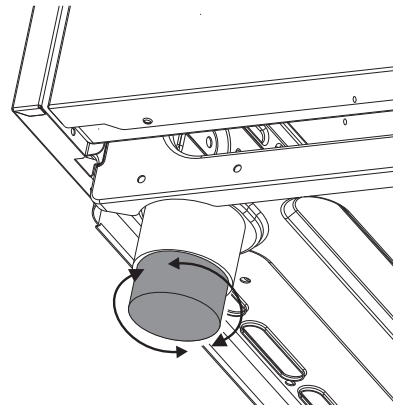
An air curtain or other overhead range hood, which operates by blowing a downward airflow onto a range, shall not be used in conjunction with the gas range unless the hood and range have been designed, tested in accordance with ANSI Z21.1 and listed by an independent testing laboratory for combination use. This type of ventilation system may cause ignition and combustion problems with the gas cooking appliance resulting in personal injury or unintended operation



3. UNPACKING, MOVING AND POSITIONING THE RANGE

CAUTION: This unit is designed as a cooking appliance. For safety purposes, never use it for warming the room or as a space heater.

- It is recommended that the grates, the griddle plate and burner heads, burner caps, front kick panel and oven racks be removed to facilitate handling. This will reduce the weight for moving.
- Remove the outer carton and packing material from the shipping base.
- Remove angle-mounting brackets from the range.
- Due to the weight, a dolly/fork lift with soft rubber tread wheels should be used to move this unit. The weight must be supported uniformly across the bottom.
- **The floor under the legs should be protected (wood, strips, carpet, paneling, etc.) before pushing the unit into position.**
- **The anti-tip device must be installed, and the gas and electrical connections should be made before the range is placed in its final position.**
- Ensure that the burner caps are correctly positioned on the burner bases on the rangetop.
- Legs should be installed near to where the appliance will be used as they are not secure for long transit. Keep the unit raised so the legs can be screwed into their couplings, then lower the range gently to prevent the legs and mounting hardware from being subject to any undue strain. Instead of tilting the unit, it is recommended that a pallet or lift jack be used.
- For proper performance the range must be leveled. The range is leveled by adjusting the four legs to ensure that the unit is on a perfectly level plane. To accomplish this, screw or unscrew the second part of the legs. The adjustment range of the screw is 1.37 inches (35 mm).



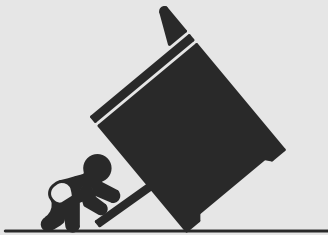

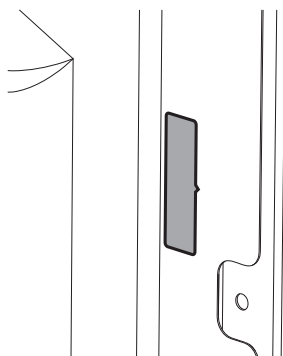
4.1 Instructions for wall mounting (primary system)

The anti-tip brackets are to be attached to the rear wall as shown. The height of bracket location from the floor is determined after the range legs have been adjusted to the installation height as shown in the installation instructions and the range has been leveled.

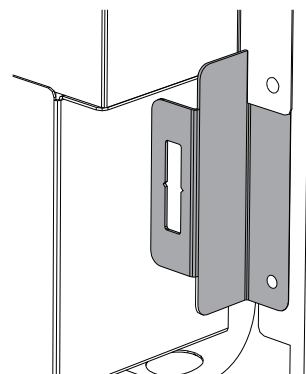
- 1 Level the range using the adjustable leveling legs.



- 2 From the floor, measure the height of the notch found on the bracket. This notch corresponds to the centerline of the holes for the screws that will fasten the brackets to the wall.

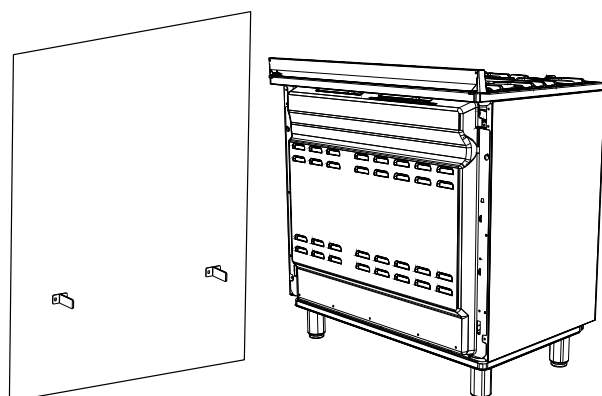

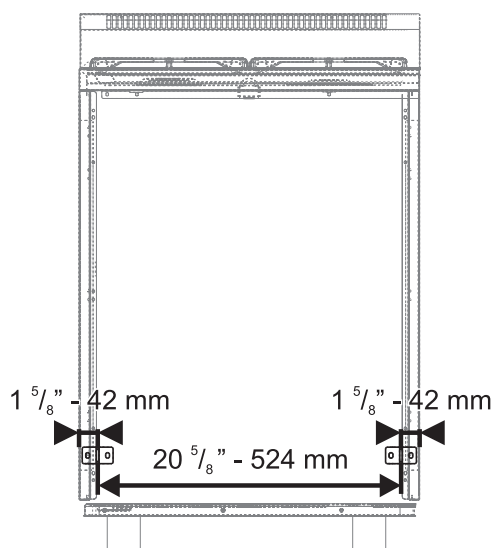
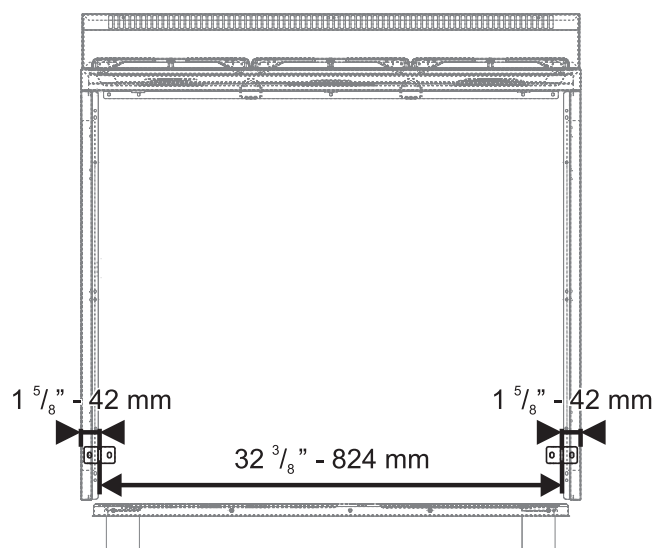
- 3 Attach the two anti-tip brackets to the wall using an appropriate fastener (for example, screws appropriate for the type of wall). Respect the heights indicated in the figures using the appliance's dimensions as a guide. (Type of screw recommended $\frac{1}{4}$ ").



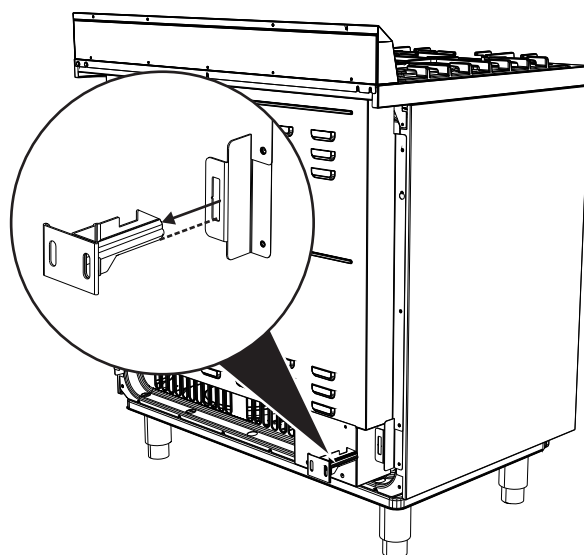
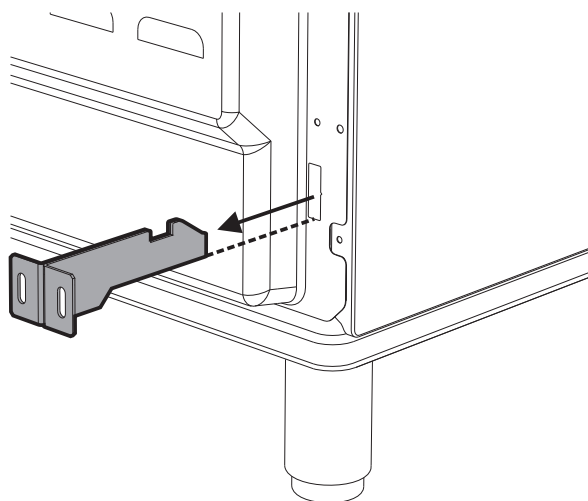

- 4 Correctly position the range so that the two screws perfectly align with the anti-tip brackets on the range.

ELECTRICAL SHOCK HAZARD

- Plug into a grounded 3-prong outlet.

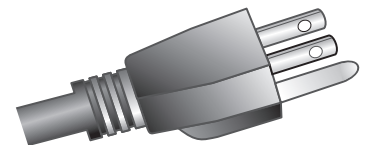
Make sure that the power line rating matches the specifications indicated on the ID plate located on the back of the appliance.

This ID plate must never be removed.

- If codes permit and a separate grounding wire is used, it is recommended that the suitability of the ground path be checked by a qualified electrician.
- Check with a qualified electrician if you are not sure whether the range is properly grounded. Do not ground to a gas pipe.
- A 120-volt, 60-Hz, AC-only, 15-ampere, fused electrical supply is required. A time-delay fuse or circuit breaker is recommended. It is recommended that a separate circuit serving only this appliance be provided.

5.0.1 Recommended Grounding Method

For your personal safety, this range must be grounded. This range is equipped with a 3-prong grounding plug. To minimize possible shock hazard, the cord must be plugged into a mating 3-prong grounding receptacle, grounded in accordance with the National ANSI/NFPA 70 Electrical Code (latest edition*) or the Canadian Electrical Code (CSA)** and local codes and ordinances. If a mating receptacle is not available, it is the personal responsibility and obligation of the customer to have a properly polarized and grounded 3-prong outlet installed by a qualified electrician.

6. GAS SUPPLY REQUIREMENTS

EXPLOSION HAZARD



WARNING



- Use a new AGA or CSA-approved gas supply line.
- Install a shut-off valve.
- Securely tighten all gas connections.
- If connected to LP, have a qualified technician ensure that the gas pressure does not exceed a 14" W.C.P.
- Examples of qualified technicians include licensed heating personnel, authorized gas company personnel, and authorized service personnel.
- Failure to do so can result in loss of life, explosion, or fire.



NOTE:

- Observe all governing codes and ordinances.
- The range must be connected to a standard gas supply.

1)

This installation must conform with all local codes and ordinances. In the absence of local codes, installation must conform to American National Standard, National Fuel Gas Code ANSI Z223.1 - latest edition** or CAN/CGA B149.1 or 2**.

2)

If local codes permit, a flexible metal appliance conductor with the new AGA or CSA design certified, 4-5 feet (1.2-1.5 m) long, 1/2" or 3/4" ID NPT, is recommended for connecting this range to the gas supply line.

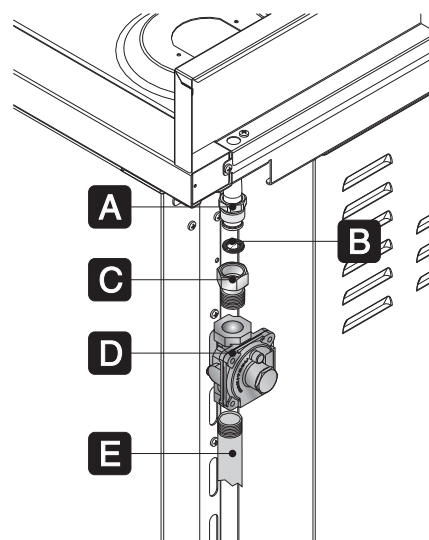
Do not bend or damage the flexible connector when moving the range. The pressure regulator has 3/8" female pipe threads. You will need to determine the fittings required, depending on the dimension of your gas supply line, the flexible metal connector and the shut-off valve.

**3)**

Always use pipe-joint compound made for use with NATURAL GAS and L.P. GAS between pressure regulator **D** and NPT adaptor **C** and between pressure regulator **D** and pipe **E**. If a flexible metal conductor is used, make sure that the tubing is not kinked.

Use only pipes (**E**) conforming to standard regulations in force, inserting gasket **B** (supplied) between fitting **A** adaptor **C**.

Always apply a suitable sealing substance (such as Teflon tape) between pressure regulator **D** and adaptor **C** and between pressure regulator **D** and pipe **E**.

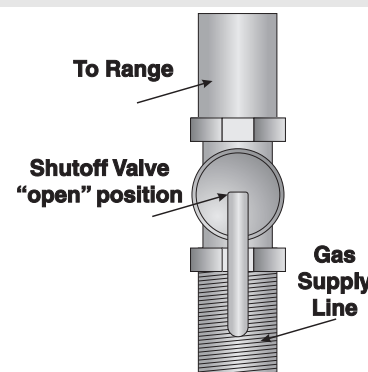


WARNING: The tightening torque of adaptor (**C**) must not be greater than 36 ozf - 10 Nm.

4)

The supply line must be fitted with an approved shut-off valve. This valve should be located in the same room as the cooktop and should be in a location where it can be easily opened and closed.

Do not block access to the shut-off valve. The valve is necessary for turning the gas to the appliance on or off.





5)

Incoming line pressure upstream from the regulator must be 1" (2.5 cm) W.C.P. higher than the manifold pressure in order to check the regulator. Incoming line pressure to the regulator should be as follows for operation and checking the regulator setting:

- **NATURAL GAS:** manifold pressure 4" W.C.P. Incoming line pressure 3.5"-10.5" W.C.P.
- **LP GAS:** manifold pressure 11" W.C.P. Incoming line pressure 8.0"-13" W.C.P.



6)

Line pressure testing: Testing above 112 PSI (3.5 kPa), with water column pressure of 14" (35.6 cm) (gauge).

The range and its individual shut-off valve must be disconnected from the gas supply piping system during any pressure testing of that system at test pressures greater than 1/2 psig (3.5 kPa).

Testing below 112 PSI (3.5 kPa) with a water column pressure of 14" (35.6 cm) (gauge) or lower.

The range must be isolated from the gas supply piping system by closing the respective manual shut-off valve during any pressure testing of the gas supply piping system at test pressures equal to or less than 1/2 psig (3.5 kPa).

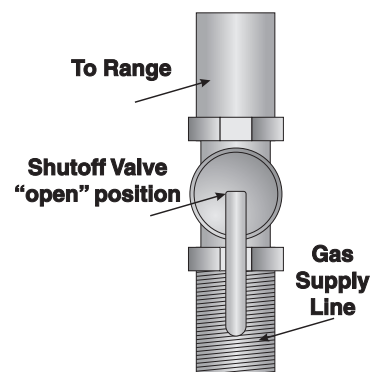

Caution: Before proceeding with the conversion, the gas supply must be shut off prior to disconnecting the electrical power.

**1)**

Check that the main gas supply line to the range is shut off and that the power supply cord is disconnected.

**2)**

Remove access cap "A" by using a screwdriver or a coin, turning the access cap counterclockwise. The gas pressure regulator has two settings which are indicated on two sides of the cap. Turn the cap and reinstall it in the regulator with "LP" visible from the outside of the regulator.

Incoming line pressure upstream from the regulator must be 1" (2.5 cm) W.C.P. higher than the manifold pressure in order to check the regulator. Incoming line pressure to the regulator should be as follows for operation and checking the regulator setting:

- NATURAL GAS: Set pressure to 4" W.C.P. Incoming line pressure of 3 1/2" - 10 1/2" W.C.P maximum;
- LP GAS: Set pressure to 11" W.C.P. Incoming line pressure 8" - 13" W.C.P. maximum.

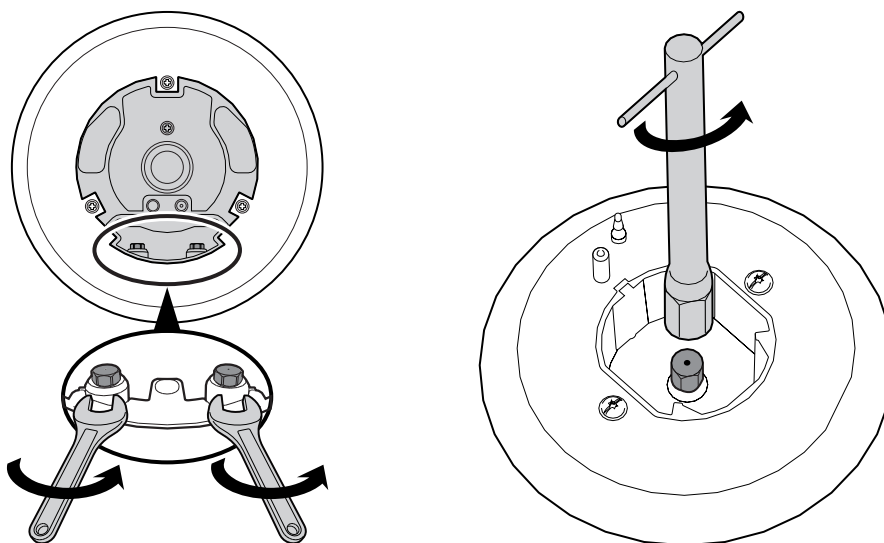


The range must be isolated from the gas supply piping system by turning off the respective manual shut-off valve during any pressure testing of the gas supply piping system at test pressures equal to or greater than 1/2 psig (3.5 kPa).

3)

Replacing the rangetop's burners nozzles (This operation does not require primary air regulation).

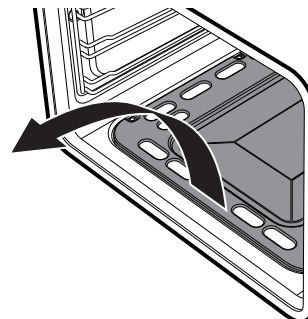
- 1 Remove the grates and all the burner caps and heads;
- 2 Unscrew the burner nozzles with a 7 mm socket wrench;
- 3 Replace the nozzles according to the type of gas to be used and the description in paragraph 3.2 "Burner and nozzle characteristics table".
- 4 Put the burners back in their correct position.



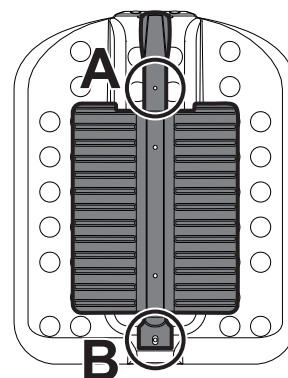


Replacing the oven's burners nozzles (This operation does not require primary air regulation).

- 1) **Oven burner:** Open the oven door and remove any accessories that are inside.
- 2) Lift up the oven surface and pull it outwards.



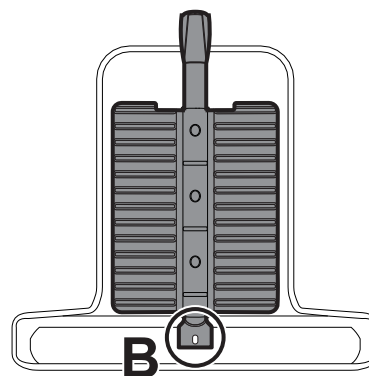
- 3) Loosen the screws **A** and **B**.

- 4) Move away the lock that secures the thermocouple and igniter to the burner with screw **A**.
- 5) Slide the burner outwards until the nozzle is accessible.
- 6) Replace the nozzle using a 7mm socket wrench.

- 1) **Broil burner:** Open the oven door and remove any accessories that are inside.
- 2) Loosen the screw **B**.



- 3) Slide the burner outwards until the nozzle is accessible.
- 4) Replace the nozzle using a 7mm socket wrench.

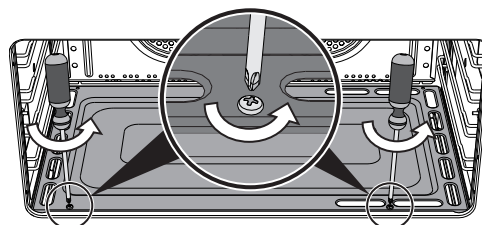


Replacing the oven's burners nozzles (This operation does not require primary air regulation).

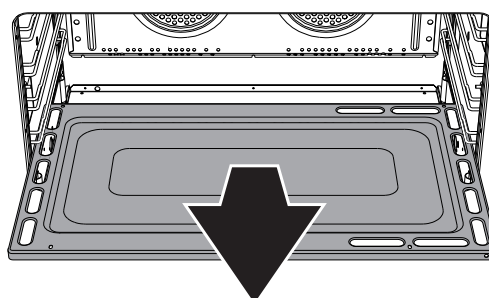

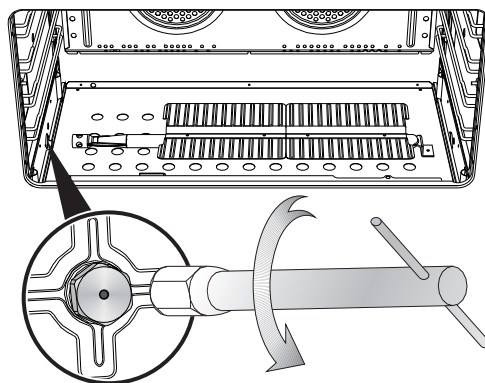


5) Remove the burner from its place by sliding it out and moving it to the side. (Make sure not to damage the thermocouple or the spark electrode during this operation).



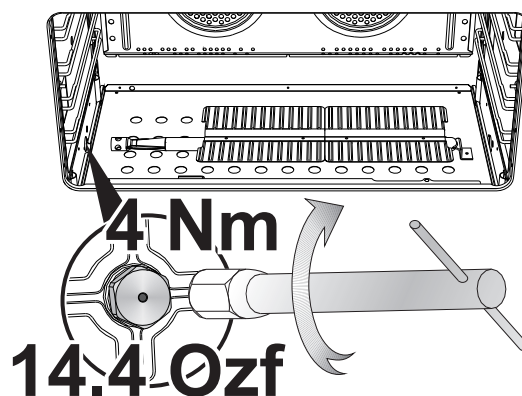


- 6) Using a 7mm socket wrench replace the nozzle, installing the one that is appropriate for the type of gas to be used. Refer to the gas charts at point 5.



- 7) **WARNING:** The tightening torque of the nozzle must be equal to 4 Nm.

After replacing the nozzle, put the burner back in its place. (Make sure not to damage the thermocouple or the spark electrode during this operation).

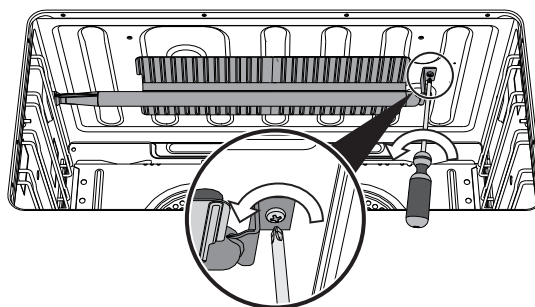


- 8) Screw in the burner's fastening screw.
- 9) Reposition the oven floor making sure to insert it correctly. The floor must be perfectly level.
- 10) Screw in the two fastening screws after having repositioned the oven floor.

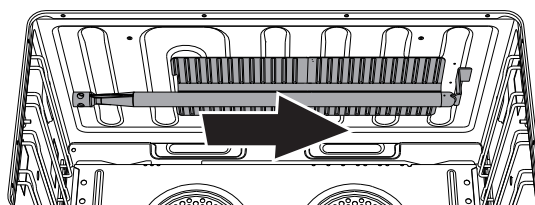


1) **Broil burner:** Open the oven door and remove any accessories that are inside.

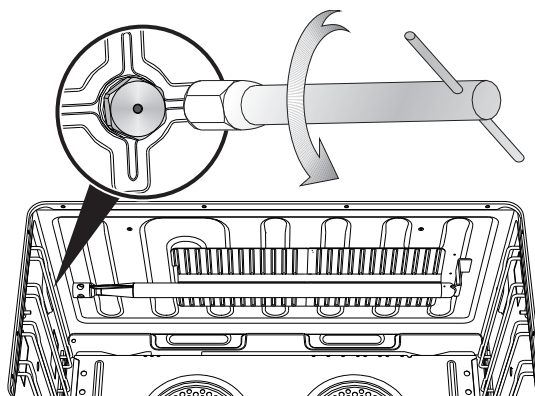
2) Unscrew the two fastening screws for the burner.



3) Remove the burner by sliding it from its place and reposition it as shown in the picture. (Make sure not to damage the thermocouples and the spark electrode).

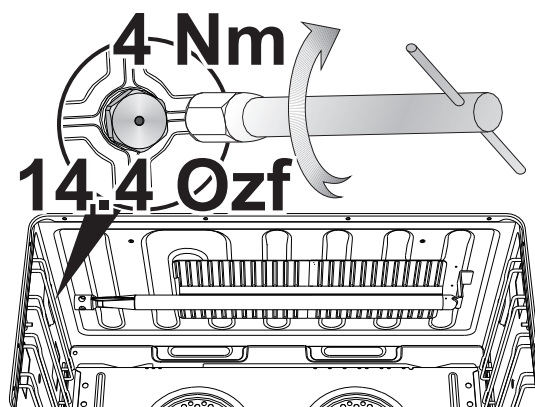


4) Using a 13mm socket wrench replace the nozzle, installing the one that is appropriate for the type of gas to be used. Refer to the gas charts at point 5.



5) **WARNING:** The tightening torque of the nozzle must be equal to 4 Nm - 14.4 Ozf.

Correctly reposition the burner in its place and screw in the two fastening screws.

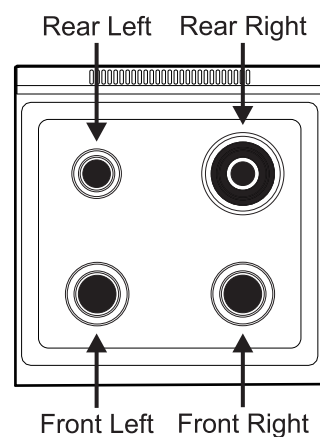




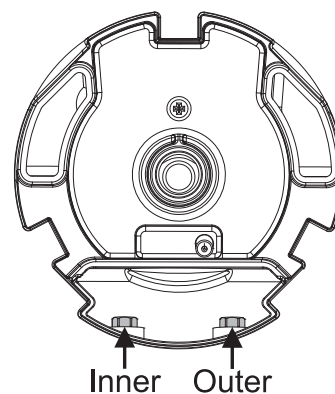

Follow these instructions to leak test the appliance:


Use a brush and liquid detergent to test all gas connections for leaks. Bubbles around connections indicate a leak. If a leak appears, shut off the gas valve controls and adjust the connections. Then check the connections again. Remove all the detergent product from the range. Replace the parts on the burner and turn the knobs on the gas tap pins.

NEVER TEST FOR GAS LEAKS WITH A MATCH OR OTHER FLAMES.

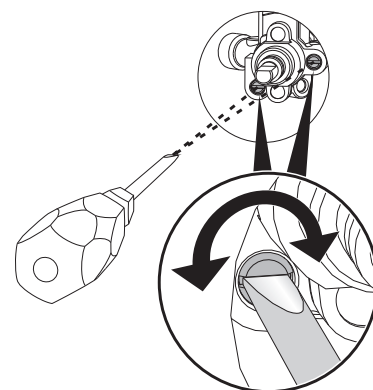

Check that the flame at the maximum flame position has a blue color. It should be clean and soft in character. No blowing or lifting of flame should occur. Occasional orange flashes are normal and reflect different elements in the air or gas.

Minimum adjustment for Natural Gas

Cooking Hob: Light the burner and turn the knob to the minimum position . Remove the gas tap knob and turn the adjustment screw at the side of the tap rod until the desired minimum flame is achieved. Refit the knob and verify that the burner flame is stable (when turning the knob rapidly from the maximum to the minimum position the flame must not go out).

Repeat this operation on the remaining gas taps on the hob.

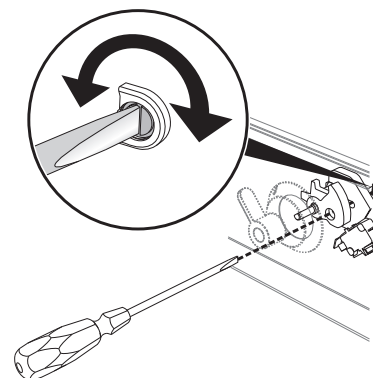

Oven: Light the burner and turn it to the maximum temperature for at least 10 minutes. Then, turn the knob to the minimum position (**LOW**). Remove the knob and, using a screwdriver, locate the adjustment screw alongside of the tap rod (as shown in the figure). Turn the adjustment screw until the desired minimum flame is achieved.

Refit the knob and verify that the burner flame is stable (when turning the knob rapidly from the maximum to the minimum position the flame must not go out).

Moreover, check that the flame does not go out when the door is being opened or closed.



Minimum adjustment for LP Gas

Turn off the burners and unplug the appliance from the electrical power supply.

For regulating the minimum with LP, the screws at the side of the tap rod must be turned clockwise all the way. Once the regulation has been completed, replace the seal on the by-passes using paint or similar materials. Follow the instructions given in point 9 to locate the adjustment screws.

Completely fill out the conversion label (part no. 92849A078) and attach it to the rear of the appliance. Do not cover any other labels with the conversion label.

12)

For installation of the appliance at high altitude, please consult your local gas company for their recommendation of the correct orifice sizes and any other necessary adjustments that will provide proper gas combustion at specified altitudes.

13)

NATURAL GAS:

To convert back to Natural Gas: Follow steps 1 through 9 and replace the nozzles in the order in which they were removed.
