  - ii)** a legible copy of your sales receipt dated between **1/1/26-12/31/26** and proof of the delivery date, if utilizing the delivery date to calculate the 30/90-day claim periods;
  - iii)** a photograph of the existing oven model that is being replaced; and
  - iv)** a dated invoice or receipt from a professional installer or contractor stating the cost to modify your existing cabinet.

## **30" SLIDE-IN RANGES**

Subject to the terms set forth herein, Maytag Brand of Whirlpool Corporation (hereafter "Maytag") guarantees your **new 30" Maytag Brand slide-in range (qualifying models listed below) featuring the FIT System** will fit your existing cut-out of 30" width, countertop depth of 24"-25", cabinet depth of 23"-24", and countertop height of 36". If your countertop cut-out depth is less than 24" and you are not satisfied with the fit of your new Maytag brand 30" slide-in range, Maytag will provide **up to \$100** toward the cost of professionally modifying the depth of your countertop cut-out. In addition, if your countertop cut-out depth is less than 24" and removal of your old range reveals uneven or slightly damaged edges on the sides of your countertop cut-out, Maytag will provide a set of two (2), (each ½ inch wide) trim pieces which are designed to cover up to ½ inch of the side edges of your countertop cut-out.
